



## **ABRA Update #13 – January 28, 2015**

### **Over 7,500 Comments Filed with GWNF**

More than 7,500 comments were filed with the George Washington National Forest by the deadline last week for views about the Atlantic Coast Pipeline application to survey; nearly 250 of the comments were substantive submissions. Several ABRA member organizations filed, including: Appalachian Mountain Advocates, Dominion Pipeline Monitoring Coalition, Highlanders for Responsible Development, Southern Environmental Law Center, Virginia Native Plant Society and Wild Virginia.
